#### 追討山景邨業主立案法團事宜

本屆(第七屆)法團管理委員會於 2021 年 8 月 15 日上任後,發現上屆(第六屆)管理委員會有大量應付賬項尚未支付,其中涉及招標程序不當、欠缺審批記錄和未有召開常務會議審議等;針對此等情況,本屆管理委員會需時核實,待澄清事實後再行處理該等應付賬項。

法團管理委員會於 2022 年 4 月 26 日收到區域法院之傳訊令狀, 迅誠工程服務有限公司向區域法院入稟,追討山景邨業主立案法團工 程費用港幣\$1,363,800 元及法律費用,要求在限期前回覆;法團管理 委員會經商議後,已經委託年度法律顧問處理。

由於尚未支付之應付賬項,涉及多間承辦商,為免引起法律糾紛 及支付額外之法律費用,本屆管理委會會儘快完成清算工作;現屆法 團亦已於上任時,委託會計師徹查第六屆法團管理委員會之賬目。
